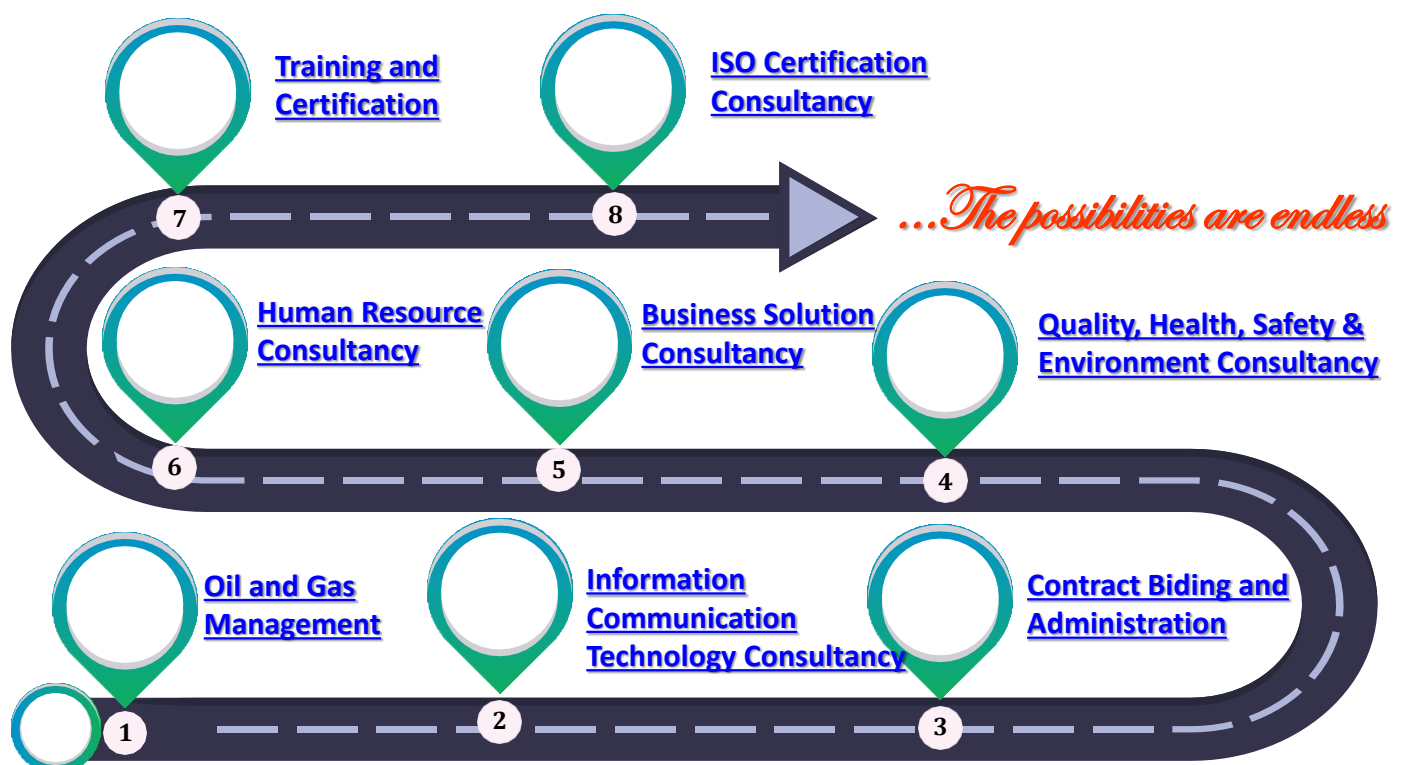

ISO 9001

Quality Management System Global Standard that spells out quality and trust.



ISO 14001

Environment Management System Internationally recognised framework for environment management, measurement, evaluation and auditing. Dedicated to manage the environment issues of organisation.



ISO 45001 & OHSAS 18001

Occupational Health and safety Management system defines the health and labour protection system of organisation



ISO 22000

Hazard Analysis and Critical Control Points Scientific approach to identify hazard in a food system eliminating or controlling hazards for safe food

GMP

Good Manufacturing Practices System to ensure products are consistently produced and controlled according to quality standards.
